Bruno called the meeting to order. There was no Treasurer's Report

Minutes from the June 8, 2109, meeting were read and accepted as written.

## Weed Treatment -

The On 6/19 Tom Hable toured the lake and the curly tail was spot treated. On 6/25, the Eurasian Milfoil was mapped and it was determined that 3.5 acres of milfoil are in the lake. ProcellaCOR was not used because the DEQ wants it to be used for 10 acres or more of milfoil. Sculpin G granular was used instead, which also kills the weeds at the roots. This has no restrictions for swimming or fishing, but the properties were posted with one day swimming restriction to be on the safe side. Should be going out in the next couple weeks to check on progress, there will be spot treatment at that time because there are still some milfoil patches.

## Water Level -

Water has been flowing out of the overflow. Lake level on 7/13, was 756.3'. The water level is high enough to keep the big rock from being a hazard for boaters.

Concern was voiced about sand being spread on beaches, which is legal. Although, it is illegal to put sand in the water and requires a permit from the DEQ.

Concern also voiced about night time fishermen taking more than the legal limit of fish. Lee Lawson called the DNR and Cass County Marine Division, was unable to reach a live person.
